This month, PTCP received and reviewed 291 proposals for LESH. We approved 220, or 75 percent. The complete statistical breakdown for the month can be found below.

CLASSIFICATION

BF1275.W65

Adding a class of persons to this caption could create confusion. The current caption is sufficient to cover the topic of the work being cataloged. The proposal is not approved.

DS888.54

This proposal accompanies a subject proposal which is being withdrawn for further examination and will be placed on a separate list. Therefore, this proposal will also be withdrawn and rescheduled.

DT474.6.K78

This classification proposal is not approved. See below under *Kruan peoples*.

DT545.45.K77

This classification proposal is not approved. See below under *Krumen (Ivorian people)*.

DT630.5.K78

This classification proposal is not approved. See below under *Krumen (Ivorian people)*.

F3430.1.T35

This classification proposal will be rescheduled to the list on which the correlating subject proposal, *Tallán Indians*, appears.

PL8423.97-9795

This classification proposal may be resubmitted with the subject proposal, *Kuswa language*. See below under *Kuswa language*.

PM5944

This classification proposal will be rescheduled to the list on which the correlating subject proposal, *Enlhet-Enenlhet*, appears.

SUBJECT HEADINGS

Asia Pacific Wars, ca.1931-1945

The proposal needs further examination due to the other headings that are affected by the proposal. The proposal is withdrawn and will be scheduled on a future list.

Besh Ba Gowah Archaeological Park and Museum (Globe, Ariz.)

Per SHM H 405, museums should be established in the name authority file. The proposal is not approved.

Camp Nelson National Monument (Ky.); National monuments–Kentucky; Military camps–Kentucky

The proposal treats this entity as both a military camp and a national monument. Per SHM H 1925 1.d.(1), parks and other geographic entities must be established separately. More information about the content of the work being cataloged is needed so that it is clear whether the content is about the monument, the camp, or both. The proposal along with its proposed broader terms may be resubmitted.

Canoes and canoeing

The proposal seeks to add Paddling as a UF. Paddling is not an activity which is exclusively associated with canoes and canoeing. The proposal is not approved.

Carapintada Uprising, Argentina, 1987

The proposal lacks an English translation or paraphrase of the work being cataloged, which is required by SHM H 202. In addition, the work being cataloged is about Holy Week in Argentina in 1987, not about a particular uprising led by the Carapintadas. The proposal is not necessary.

Chronology, Somali

The summary of the work being cataloged discusses calendars and features of calendars. The cataloger should consider proposing *Calendar, Somali*. The proposal is not approved.

El Caño Site (El Caño, Panama : Corregimiento)

The subject heading **Caño Site (Panama)** already exists. The proposal is not approved.

Electric power systems—Cost of operation

This subject string was proposed as a broader term for *Levelized cost of energy*, which was determined to be a metric for energy costs, not an electric power system. The proposal is not approved.

Electronic courts

Though the work being cataloged bears the title “electronic courts” the supporting literary warrant describes digital filing systems used in courts. The term “electronic courts,” is not listed in *Black’s Law Dictionary* or *Oxford Dictionary of Law*. The headings **Courts-Jordan-Automation** or **Court administration-Jordan-Data processing** and **Electronic filing systems** can be applied to the work being cataloged. The proposal is not approved.

Escarrá family

The information from the work being cataloged does not give sufficient evidence that the family being referenced is the Escarrá family. If more information about the content of the resource is given, the proposal may be resubmitted.

Eugene Dupuch Law School

Per SHM H 405, schools must be established in the name authority file. Moreover, this named entity already exists in the name authority file. The proposal is not approved.

Fingerpicking

Per SHM H 1916.3 section 3.k, specific performance techniques are expressed as subdivisions for headings for musical instrument headings. This proposal is not approved as a subject heading but will be established as a new free-floating subdivision.

Germany–Intellectual life–Chinese influences; Philosophy, German–Chinese influences

Information about the work being cataloged beyond the title is lacking. More research about and evidence of the relationship between Chinese influences, the Jesuits, and philosophical movements situated in Germany is necessary. These proposals may be resubmitted.

Gramling family

This proposal seeks to add the *Gramling family* name as a UF to the heading **Gramlich family**, but this difference in spelling is significant and reflects a change caused by immigration. The proposal may be resubmitted along with a proposal for **Gramlich family**, each as a related term to the other.

Grebo (African people)

The proposal seeks to change the broader term **Kru (African people)** to *Kruan peoples* but provides no justification for this change. More information about the proposal for *Kruan peoples* is given below. The proposal is not approved.

Guayaquil Massacre, Guayaquil, Ecuador, 1922; Massacres–Ecuador

The work being cataloged comparatively examines the General Strike in 1922 and the strike in Ecuador during the COVID-19 pandemic, referring to them collectively as “massacres.” More information from the work being cataloged is needed in order to demonstrate that the massacre that resulted from the General Strike in 1922 in Ecuador is referred to by the name being proposed. The proposal may be resubmitted with the companion subject proposal for *Massacres–Ecuador*.

Hotchkiss M201 automobile; Hotchkiss automobiles

The proposal for *Hotchkiss M201 automobile* was made to change the heading **Hotchkiss automobile**. A new proposal was made for *Hotchkiss automobiles*. The reverse should have happened. The proposals may be resubmitted: a change proposal for the existing heading **Hotchkiss automobile** (singular) to *Hotchkiss automobiles* (plural) and a new proposal for *Hotchkiss M201 automobile*.

Indians of North America–Boats

The proposal was made to modify the current heading **Indians of North America–Boats** but no change was provided. The proposal is not necessary.

Jabo (African people)

The proposal seeks to add the broader term **Grebo (African people)** based on a citation that claims Jabo is a dialect of Southern Grebo. More research beyond the languages or dialects used by the Jabo people is necessary to demonstrate a connection between the Grebo and Jabo people. The proposal may be resubmitted.

Jabo dialect

The proposal seeks to change the established heading **Jabo language** to *Jabo dialect*. The work being cataloged, however, refers to Jabo as a language. More research is necessary to show that Jabo is considered a dialect. The proposal may be resubmitted.

Keagy family

The proposal seeks to add the related family name *McCaig*, but insufficient justification is given. References to a common etymology are not reason enough to connect the family names. The proposal is not approved.

Khap sepha; Storytelling-Thailand

More information should be provided from the work being cataloged. The additional authority research included in the proposal creates confusion since it appears that Sepha is different from Khap sepha. These proposals may be resubmitted.

Korea-Social life and customs-1637-1864

The work being cataloged discusses the late Chosun Dynasty but dates for this period are not provided. Consult SHM H 620 section 3 for establishing subdivisions for time periods. The proposal may be resubmitted.

Kouya (African people)

This proposal seeks to add *Kruan peoples* as a broader term. *Kruan peoples* is a proposal deemed unnecessary (see more below). Therefore, this proposal is also not necessary.

Kru (Liberian and Sierra Leone people)

The proposal for *Kru (Liberian and Sierra Leone people)* seeks to establish a new heading for the Kru people by identifying the particular geographic regions where they reside. The established heading for **Kru (African people)** comprises people who live throughout West Africa, which covers all the territories identified in this proposal. The proposal is not approved.

Kru language-Conversation and phrase books-English; Kru language-Conversation and phrase books-Vietnamese

The justification given for canceling these headings is that they replicate *Bru language-Conversation and phrase books-English* and *Bru language-Conversation and phrase books-Vietnamese*. Bru language is part of a language group that spans the geographic regions Laos, Mon-Khmer, Thailand, and Vietnam. Kru language is part of a language group found in Liberia. These are not the same language, so one heading is not covered by the other. The proposals are not approved.

Kruan peoples

The proposal seeks to use a language common to many peoples, Kruan, to justify the existence of a distinct group of people. However, it is not clear from the proposal that Kruan peoples are a distinct group. *Kruan languages* has also been proposed as a variant of **Kru**

languages, but insufficient justification was provided for its addition. Kru languages are spoken by the Kru people for which the heading, **Kru (African people)**, already exists. The proposal is not necessary.

Krumen (Ivorian people)

The work being cataloged refers to the Krou people. Krou (African people) is a UF under the established heading **Kru (African people)**. The proposal is not approved.

Krumen languages; Tepo language

The work being cataloged refers to Krumen as a dialect. The supporting research has an ellipsis that makes it difficult to understand what is being discussed. The proposal for *Tepo language* seeks to change **Kru languages** to *Krumen languages* as the broader term. When more research is done to clearly justify why Krumen is a dialect and not a language, both proposals may be resubmitted.

Kuswa language

The meeting requests more research on the rationale for considering Kuswa a language instead of a dialect, since sources differ on this point. The proposal may be resubmitted.

Lebanese students

No English translation or paraphrase is given for the work being cataloged, as required by H 202. When an English translation or paraphrase is provided that explains the relationship of the work to the heading being proposed, the proposal may be resubmitted.

McNeil family

This proposal seeks to add the *McGrail family* name as a use for reference to the heading **McNeil family** based on the work being cataloged which is solely about the McGrail family. An etymological similarity between the names does not make them variants of one another. The degree of difference is such that the *McGrail family* should be established as heading in its own right, with a related term reference to the **McNeil family**. This will result in a second proposal to add *McGrail family* as a related term to the **McNeil family**. If the *McGrail family* name heading is proposed, the **McNeil family** proposal may be resubmitted.

Merchant mariners–Africa, West

The subject heading *Merchant mariners* is already authorized for use with a geographic subdivision. Therefore, it does not require editorial establishment. The proposal is not necessary.

Niao (African people)

While the work being cataloged justifies the proposal, the supporting research calls it into question. Variant names for the Niao are justified by names of dialects. Other variant

names come from two different chiefdoms. More research is necessary to distinguish this group from the other tribes and clans that are identified with the ethnic groups of the Krahn people. The proposal may be resubmitted.

Olympics—Participation, Hong Kong (China)

Following the existing pattern, when the topical heading **Olympics** is used with the subdivision **-Participation**, which is then followed by a comma, the nationality, not the nation, should be used. Use **Olympics—Participation, Chinese**. The proposal is not approved.

Rice farming—Religious aspects

The work being cataloged is about the prayers used to bring rain for rice crops. It is recommended that the cataloger assign **Rice farming**, postcoordinated with **Prayers for rain** and/or **Rain-making—Religious aspects**, to the work being cataloged. The proposal is not necessary.

Tchien dialect

The proposal seeks to change **Tchien language** to *Tchien dialect*. The work being cataloged should have more information about Tchien, whether it is a dialect or language. Once the corroboration of sources is made, the proposal may be resubmitted.

Tower of Mortella (Corsica, France)

The work being cataloged is about a shipwreck named after the site of the tower. The proposal is not necessary.

Wirral Colliery (England)

More information is necessary about the locality of Wirral Colliery. More information from the work being cataloged must be supplied. Additional authority research is necessary. Consult SHM H 690 for a list of recommended authoritative sources. The proposal may be resubmitted.
