**ACCOMPLISHMENTS SINCE ALA MID-WINTER MEETING:**

- Drafted guidelines for creating post-cataloging series authority records; PoCo approved; Guidelines forwarded to LC's Policy and Standards Division and PCC's SCT in order to update documentation as needed.
- Submitted formal comments on the Interim Report of the Task Group on BIBCO Standard Record Requirements to PoCo on March 30.

***Status:*** In May, the task group finished the chart mapping all of the LCRI's to corresponding RDA rules. The chart indicates which LCRI's should be retained in full, which should be retained but revised, and which can be omitted. Additionally, initial recommendations were made on the options/alternatives that had previously been identified as "decision needed." Task group members will also be reviewing RDA "options," once the final product is available, and recommending PCC preferences to ensure consistency of application.

**Status:** Following up on the recommendation II.3 of the *Task Force on Non-English Access*. Rev. Mar 16, 2007, “to review and update the core level supplement on “Guidelines for Multiple Character Sets,” SCS discovered this was only one of many documents needing revision. During the May 2008 OpCo meetings, a recommendation was made to form a PCC task force to produce documentation for entering non-Latin scripts in PCC bibliographic records. The task force was formed and began work during the spring. They are currently drafting their interim report, *PCC Guidelines for Creating Bibliographic Records in Multiple Character Sets*, which has a due date of July 31. The report will address the languages/scripts covered by the MARC -8 repertoire of UTF-8: Japanese, Arabic, Chinese, Korean, Persian, Hebrew, Yiddish, Cyrillic, and Greek.

  - This Task Group, reporting to SCA, will be exploring options to improve automatic augmentation of master records in the WorldCat database.
