BACKGROUND: Before the adoption of AACR2 in 1981, many individual treaties and concordats were established in the subject authority file when they were needed as subject headings. Since 1981, only treaties or concordats established in AACR2 or RDA form in the name authority file may be validly assigned as subject headings. Most pre-AACR2 treaty headings have already been deleted from the subject authority file. Remaining headings of this type are cancelled as they are encountered, and are re-established in the name authority file.

1. Texts of treaties.

- a. General (non-topical) collections. Assign the appropriate general form heading, for example, Treaties—Collections; Peace treaties; [place]—Foreign relations—Treaties.
- b. Topical collections.
 - (1) Topical headings. Assign the appropriate topical heading(s), for example, Environmental law, International; Chemical warfare (International law); Postal conventions; Commercial treaties; Sex discrimination against women—Law and legislation; Choctaw Indians—Treaties; World War, 1939-1945—Treaties.

Note: The subdivision —**Treaties** is used only under names of ethnic groups, under names of wars, and under **Catholic Church**—**Foreign relations** and headings of the type [place] —**Foreign relations**. It is not used as a further subdivision after headings of the type [place] —**Foreign relations**— [place].

Examples:

Title: Labour law ratified conventions.

- **b.** Topical collections. (Continued)
 - (2) Geographic subdivision. If the purpose of the collection is to present the treaties to which a particular country is a party, assign a general heading, without local subdivision, to bring out the international aspect, and assign the same heading with local subdivision to bring out the country (except for collections of commercial treaties, for which the heading [country]—Commercial treaties is used as the second heading). Example:

Title: United States treaties and other international agreements pertaining to telecommunications.

Exception: If the collection is limited to only two countries, omit the general heading, and bring out both countries using local subdivision. Example:

Title: Trade in cotton textiles: agreements between the United States and Poland.

c. Individual treaties.

(1) General rule. Assign the appropriate topical heading(s) using the same types of headings as for topical collections.

Do not assign the heading for the name of the treaty itself to a work that consists solely of the text of the treaty.

2. Works about treaties.

a. Collective. To works that discuss various treaties to which a region or country is a party, assign the heading [place]—Foreign relations—Treaties or [place]—Commercial treaties, as well as other topical headings appropriate to the work. Examples:

Title: Theory, law, and policy of contemporary Japanese treaties. 651 #0 \$a Japan \$x Foreign relations \$y 1945-1989 \$x Treaties.

Title: The long pretense: Soviet treaty diplomacy from Lenin to Gorbachev
