**PETITION TO PARTICIPATE AND COMMENTS
OF THE PUBLIC TELEVISION CLAIMANTS**


The Public Broadcasting Service (“PBS”), on behalf of public television stations and the copyright owners of programs broadcast by public television stations that are retransmitted by cable operators (the “Public Television Claimants”), hereby submits the following Petition to Participate and Comments of the Public Television Claimants in response to the Copyright Royalty Judges’ notice published at 73 Fed. Reg. 18004 (April 2, 2008). A \$150 filing fee accompanies this filing.

The only Phase I issue that remains to be resolved in the above-captioned proceeding is the share of the 2000, 2001, 2002, and 2003 cable royalty funds (“2000-03 Funds”) to which the Canadian Claimants are entitled. Representatives of all of the Phase I categories to which royalties have been allocated in prior cable royalty distribution proceedings (“Phase I Parties”) have settled all other Phase I controversies regarding distribution of the 2000-03 Funds and agreed on how to divide all royalties other than the Canadian Claimants’ share among themselves. The Phase I Parties notified the Judges and the Copyright Office of these partial settlements in prior submissions. *See*

Phase I Claimants' Notice of Partial Phase I Settlement and Motion for Further Distribution, Docket No. 2005-4 CRB CD 2003 (June 8, 2007) (2003 cable royalties), *acknowledged in* 72 Fed. Reg. 46516, 46518 (August 20, 2007); *Phase I Claimants' Notice of Partial Settlement and Motion for Further Distribution*, Docket Nos. 2002-8 CARP CD 2000; 2003-2 CARP CD 2001; 2004-5 CARP CD 2002 (December 6, 2005) (2000, 2001, and 2002 cable royalties).

PBS and the Public Television Claimants have a significant interest in the subject matter of this Phase I proceeding because they own or represent owners of copyrighted works broadcast by public television stations that were retransmitted by cable systems during the relevant periods. The Public Television Claimants have participated in cable royalty distribution proceedings for the past several decades and have received a share of the cable compulsory royalty funds for each year that the funds have been distributed. The undersigned hereby certify that they have the authority and consent of PBS and the participants named in Attachments A (2000), B (2001), C (2002), and D (2003) to represent them in this royalty distribution proceeding.


