**INDEPENDENT PRODUCERS GROUP'S
PETITION TO PARTICIPATE IN PHASE II PROCEEDINGS**

Worldwide Subsidy Group LLC (a Texas limited liability company) dba Independent Producers Group ("IPG"), pursuant to the *Notice announcing commencement of Phase II proceeding with request for Petition to Participate*, published August 16, 2013 by the Library of Congress, 78 Fed. Reg. 50113, hereby notifies the Copyright Office as follows:

IPG maintains claims in the syndicated programming, sports programming, and devotional programming categories, typically as an assignee of rights. IPG asserts that a controversy exists with respect to the 2004-2009 cable royalty funds in Phase II of the syndicated programming, sports programming, and devotional programming categories with regard to programming initially owned or controlled by those parties identified on the attached Exhibit A.

IPG notifies the Copyright Office of its intent to participate in any Phase II proceeding involving syndicated programming, sports programming, and devotional programming. It files this as a Joint Notice on behalf of itself and all the parties listed in the attachment hereto.

IPG reserves the right to amend its list of represented participants as such amendments may be necessary and legally permissible. As of the date of the Petition to Participate, IPG and its undersigned counsel certify that they have the authority and consent of each of the parties listed on the attachment to represent them in the 2004-2009 Phase II proceeding. For purposes of clarification, certain of the parties assigned rights to IPG, or made independent claims, for less than the aggregate of 2004-2009 calendar years. As the copyright owners and holders of programming broadcast on stations whose

signals were carried by cable systems as distant signals in 2004, 2005, 2006, 2007, 2008 and 2009, IPG and the parties listed on the attachment have a significant interest in the subject matter of these Phase II proceedings.

As required by the Judge's notice, IPG has attached a check with their \$150 filing fee, payable to the Copyright Royalty Board.
