**SUBJECT: Serials BOAs for Fiscal Year 2003-2004**

Basic Ordering Agreements (BOAs) for Fiscal Year 2003-2004 Serials Subscription Services under the FEDLINK program are listed below. BOA numbers and points of contact are provided. This information alert has been modified to remove Faxon from the list of FEDLINK serials subscription vendors.

Current customers may renew subscription services for FY04, the remaining option year for the serials basic ordering agreements. The following instructions are for new customers or for those who need to recompetete, for example because agency requirements have changed significantly.

New or changed agency requirements must be competed among the selected vendors. Accounts over \$25,000 must be announced in *Federal Business Opportunities* (<http://www.fedbizopps.gov>). LC Contracts will prepare announcements for Transfer Pay customers; Direct Pay customers will need to work with their agency's contracting officials.

Transfer Pay customers should complete the online *Intent to Compete Serials Subscriptions* form at <http://www.loc.gov/flicc/onlinedoc/pssu.html>. Members may use the form as a cover sheet to submit a title list and, if necessary, any special technical requirements. (Both of these items may be sent after submitting the Intent to Compete Serials form electronically.) All Transfer Pay serials requirements must be sent to LC Contracts **60 days** (or earlier) before the serials subscription start dates.
