## Description/Instructions

Field 700 contains personal names used as added entries. Words, phrases, initials, or symbols used by an author to conceal his identity are considered personal names.

For serials, this field is most commonly used for editors of serials or for persons responsible for the publishing/issuing of a serial. For integrating resources, it may be used for persons credited with having some role in creating the content of the resource, but not chosen as the main entry for the record.

### First indicator

The first indicator describes the form of the name.

#### 0 - Forename.

Consider as forenames: names having the structure of forenames (direct order), initials in direct order, or a characterizing phrase in direct order. In case of doubt as to whether a name is a forename or a surname, consider it a forename.

Consider as surnames: names formatted in inverted order (surname, forename) or names without forenames when known to be surnames. ## Description/Instructions

Field 710 contains names of corporate bodies used as added entries. (For a definition of a corporate body, see field 110.) Conferences are also recorded in field 710 when they are entered subordinate to a corporate body.

### First indicator

The first indicator is based on the type of corporate name. First indicator value "1" is used when the corporate body is a jurisdiction or a jurisdiction followed by a name. Value "2" is used when the corporate body is entered directly under its own name.

ISSN for a serial contained in the title portion of a name/title field. The ISSN is an agency-assigned data element. ISSNs are assigned to serial publications by national centers under the auspices of the ISSN Network.

### Description/Instructions

Field 730 is used in serial records for authoritative added entries for works entered under title that have a relationship to the serial being cataloged. An "authoritative" entry is one that is represented in the name authority file or by a bibliographic record. Headings for non-authoritative title added entries not relating to the title given in field 245, such as titles of portions of a work, are tagged 740. Field 730 is also used for names of radio and television programs, motion pictures and video recordings, and anonymous works.

The title proper or the uniform title heading, whichever is appropriate as the main entry, is used as the added entry for the related record. For related publications such as supplements and online versions, the 730 may duplicate the linking entry field, and neither field should be omitted.

Titles for related serials given in field 730 must be represented by either an *AACR2* CONSER record, an added entry on an *AACR2* CONSER bibliographic record, or a name authority record. If an *AACR2* CONSER representation is not available, create a NAR or code the record as "msc" (for minimal level cataloging). When authoritative, code "lc", "nlc" or "lcd" is used on the serial being cataloged, regardless of whether the authoritative form of the 730 is in the bibliographic data base or in the name authority file.

## Description/Instructions

Field 740 is used for title added entries that are not authoritative. "Non-authoritative" titles are those that are not represented by a name authority record or by an *AACR2* CONSER bibliographic record in which that title appears in field 245. For serials, field 740 may be used for titles of sections/parts or works contained within the item that are not authoritative (e.g., supplements that are not separately cataloged). Field 740 is also used to record the title for an online version when that format is not cataloged separately and the title differs.

Input variant titles of the work being cataloged in field 246. Input titles of related works that are authoritative in field 730.

The first indicator specifies the number of nonfiling characters to be ignored for sorting purposes. Initial articles are omitted according to CONSER policy, therefore, the first indicator is always set to value "0".

Second indicator value "2" is used for titles contained within the item (i.e., analytical entries). Title added entries that are not analytical entries are coded as blank. See examples above.

Field 752 contains the hierarchy of geographic entries representing place of publication. This field is used only in records for newspapers and rare serials. The 752 field can be used to generate machine-ordered lists of catalog records, arranged by place name, and some catalog systems index the field. The current *AACR2* form of the place name is recorded, including the country name and subordinate units (subfields \$a through \$d).

This field is established as a core element for newspaper records although only subfields \$a and \$d are considered mandatory (*CEG* B6.4.2; *CCM* 33.14). When a newspaper changes its place of publication an additional 752 field is input for the new place name.

Under earlier practice field 752 was used for a newspaper's area of coverage, if it differed from the place of publication. The 651 field is currently used for a newspaper's area of coverage. The 752 field was also used to record unauthorized, and earlier forms of place names. This information can be recorded in reference in authority records.

### Subfields

For U.S. titles, record the currently established form of the state name in subfield \$b. For parts of Great Britain, record the appropriate name in subfield \$b (e.g., England, Northern Ireland, Scotland, Wales). Record the province or territory in subfield \$b for Australia, Canada, Malaysia, and Yugoslavia.
