

LAWS OF THE CHOCTAW NATION.



BILL NO. 1.

CHAHTA TAMAHA, C. N., October 12, 1881.

To the General Council:

Your committee on the Chief's message would respectfully recommend the adoption of the following resolution in reference to Col. Peter P. Pitchlynn, Col. Forbis Leflore and Capt. John Mishimahtabee:

Resolved, That it is a public duty to make grateful recognition of the long and distinguished services and usefulness of Col. Peter P. Pitchlynn, who died at Washington City, D. C., February 17, 1881, and whose services commenced with the first efforts made by the Choctaws to have written laws for their own government, and at the same time to establish schools for the education of their children while the Choctaws were east of the Mississippi.

That his services thus early commenced unremittingly continued to the time of his death.

That he contributed largely to the forming and perfecting the form of the Choctaw government, as well as to creating school funds which now support and maintain the schools of the Choctaw Nation, and that he was a strong friend to temperance, morality, religion and good order among his people.

That the services of Capt. John Mishimahtabee and Col. Forbis Leflore, who died at their respective homes, commenced in this country and were identified with every effort made for the advancement and improvement of the best interests of their people, and that they were also

at heart, true friends of the prosperity and happiness of the Choctaw people.

That the Choctaw Nation has suffered serious loss by the deaths of these three distinguished men.

That the usual badges of mourning be worn by the members of the General Council and National Officers for thirty days.

That an authenticated copy of this resolution be sent to the family of each of the said, Col. Peter P Pitchlynn, Col. Forbis Leflore and Capt. John Mishimahtabbee, by the National Secretary.

That the General Council adjourn on Friday, Oct. 14th, to the Saturday, 1881, in respect to the memory of the said Col. Peter P. Pitchlynn, Col. Forbis Leflore and Capt. John Mishimahtabbee.

Your committee beg leave to be now discharged from the reference of the above subject.

BILL NO. 2.

An Act amendatory of an act to prescribe the duties of the National Secretary, and to establish his salary. Approved October 16, 1860:

SECTION 1. Be it enacted by the General Council of the Choctaw Nation assembled. That it shall be the duty of the National Secretary, as soon as practicable after each session of the General Council, to have enough copies of all the acts, resolutions, treasurer and auditor's reports of each session thereof respectively printed and published in substantial pamphlet form, on good paper, in both Choctaw and English, to furnish and send one copy of each language to every officer of the Choctaw government, and reserve for the Nation one dozen copies of each besides, to be deposited in the archives of said Nation to meet fu-

ture contingencies, and then if any surplus copies be left, the said National Secretary may dispose of the same on his own personal account.

SEC. 2. Be it further enacted, That Section 3 of the said act, approved October 16, 1860, is hereby repealed; that this act is intended also to supersede the office of Translator for the General Council, and all that part of the law which provides for the appointment and pay of said Translator.

SEC. 3. Be it further enacted, That an additional annual compensation of three hundred and fifty dollars is hereby allowed the National Secretary to meet and pay for all additional labor herein imposed and all expenses contingent or otherwise of his office; said additional annual compensation to be drawn upon his own certificate, upon which the National Auditor shall issue his warrant, and the National Treasurer shall pay the same

SEC. 4. Be it further enacted, That this act take effect and be in force from and after its passage. Proposed by

BILL NO. 3.

A Resolution expressing profound gratitude to the United States for the prompt and efficient services of the military in expelling intruders:

Be it resolved by the General Council of the Choctaw Nation assembled, That it is the duty and desire of the Choctaw people to make expression of their profound gratitude and universal joy for the prompt and efficient manner in which the intruders were expelled from Mosholatabbe District and along the line of the M., K. & T. Railway by the U. S. Indian Agent, Col. John Q. Tuft, assisted by the military, and thus relieving those localities of a dangerous element, where they were getting too numerous, troublesome and defiant.

That by the services of the U. S. soldiers the Choctaw Nation feels assured that its rights and local laws shall be respected and enforced by the government of the United States whenever it becomes necessary, or requested by the authority of the Choctaw Nation; and that the Choctaw people hope they shall receive such services of soldiers in the future, whenever it shall be necessary, so that the friendship and good faith ex-

isting between the United States and the Choctaw Nation may continue.

That the Choctaw people are also thankful to the Secretary of the Interior, Commissioner of Indian Affairs and Acting Attorney-General for their opinions and decisions by and through which the permit law was approved and enforced.

That the Principal Chief is hereby requested to send an authenticated copy of this resolution, each to the Secretary of the Interior, Secretary of War, Attorney-General of the U. S., Commissioner of Indian Affairs and U. S. Indian Agent, John Q. Tufts.

That this resolution shall take effect from and after its passage.

BILL NO. 4.

A Resolution making appropriation to pay D. W. C. Duncan for legal services in the trial of D. L. Payne, at Fort Smith, Ark.

Resolved, That the sum of five hundred dollars is hereby appropriated out of any money not otherwise appropriated, to pay D. W. C. Duncan for legal services rendered in the prosecution of D. L. Payne before the U. S. court at Fort Smith, Ark.; and the National Auditor is hereby directed to issue his warrant accordingly, and the Treasurer shall pay the same, and this resolution shall take effect from and after its passage.

BILL NO. 5.

A Resolution authorizing the Principal Chief to appoint one competent person to proceed with the prosecution of the claim of the Choctaw Nation against the Missouri, Kansas and Texas Railway:

Be it Resolved, By the General Council of the Choctaw Nation assembled, that the Principal Chief is hereby requested and authorized, with the advice and consent of the Senate, to appoint one competent person—a citizen of the Nation—whose duty it shall be, in conjunction with a similar representative of the Chickasaw Nation, to prosecute the claim of the Choctaw and Chickasaw Nations against the Missouri, Kansas and Texas Railway, and to continue the same until allowed and collected.

That the necessary expenses of the person so appointed shall be paid by the Choctaw Nation.

That the attorney employed by the representatives of said Nations shall receive a fee of a reasonable amount contingent upon recovery and collection of said claim; three-fourths of said fee to be paid by the Choctaw Nation.

That said representative of the Choctaw Nation shall report the result of his proceedings in this behalf to the Principal Chief, to be by him presented to the General Council.

And this resolution shall take effect and be in force from and after its passage.

BILL NO. 7.

A Resolution making an appropriation of a reward for the arrest and delivery of the murderer of the late sheriff of Scullyville county:

Be it Resolved, By the General Council of the Choctaw Nation assembled, that the sum of one thousand dollars is hereby appropriated out of any money not otherwise appropriated, as a reward for the arrest and delivery to the U. S. court at Fort Smith, of one William Hughes, a citizen of the United States, who so wantonly murdered Joseph Lanier, the late sheriff of Scullyville county, in the town of Scullyville, in the month of September, 1881.

Resolved further, That the Principal Chief is hereby authorized to make publication of the above offer, and upon the receipt of the U. S. Marshal at Fort Smith, Ark., of said William Hughes, the Principal Chief is further authorized to certify the same to the National Auditor who shall issue his warrant accordingly, and the Treasurer shall pay the same; and this resolution shall take effect and be in force from and after its passage.

BILL NO. 8.

An Act to grant to John M. Hodges the privilege to build a bridge over Clear Boggy Creek on the Atoka and Boggy Depot road, and establish a toll gate thereon:

SECTION 1. Be it enacted by the General Council of the Choctaw Nation assembled, That the privilege is hereby granted to John M. Hodges to build a bridge over Clear Boggy Creek, just below the mouth of Delaware Creek, on the road from Atoka to Boggy Depot, and establish a toll gate thereon, upon the following conditions: That if the said John M. Hodges shall erect a good and substantial bridge over Clear Boggy Creek, at the above mentioned place, and shall keep said road in good order and condition for four hundred and forty yards on either side of said bridge, he shall be entitle to demand and receive therefor from all persons passing over the said bridge, except from citizens of this Nation, the following rates of toll, to-wit: For each four-wheeled wagon or other vehicle drawn by four or more horses, mules or

oxen, with driver, the sum of fifty cents; for each four-wheeled wagon or other vehicle drawn by one or two horses, mules or oxen, with driver, the sum of twenty-five cents; for each man and horse, ten cents; for each person on foot five cents; for each animal in every drove of cattle, horses, hogs and sheep or other animals, one cent.

SEC. 2. Be it further enacted, That the privilege to collect toll herein granted, shall take effect and be in force whenever the said John M. Hodges shall well and truly erect said bridge, and continue so long as he shall keep the said bridge and road in good order; and the privilege herein granted shall not continue for a longer time than ten years.

SEC. 3. Be it further enacted, That this act take effect and be in force from and after its passage.

An Act removing Big Lake precinct in Atoka county to Sulphur Springs :

Be it enacted by the General Council of the Choctaw Nation assembled, That Big Lake precinct in Atoka county is hereby removed to Sulphur Springs, about three miles north of Big Lake, and shall be called and known as "Sulphur Springs Precinct;" and this act shall take effect and be in force from and after its passage. BILL NO. 12.

An Act amendatory to an act prohibiting the obstructing or shutting up of public roads. "Approved October 8, 1836."

Be it enacted by the General Council of the Choctaw Nation assembled, That any person or persons who may have or may hereafter obstruct, or shut up public roads, or road leading to church, or school, by a fence of any kind whatever, shall be compelled by the county court in which such obstruction is made, to make a good substantial road around such fences, or to make a lane, or to make gates at the point where the original road comes in and out, for free and ready ingress and egress through such fence or fences.

Be it further enacted, That the person or persons who have obstructed or shut up the roads as aforesaid, fail or neglect to obey the order of the court, shall be fined by the county court in the sum of \$25 in cash, with which sum to cause a good road to be made around, to make a lane through, or to put gates, to allow free passage through such fence or fences.

Be it further enacted, That the one dollar fine as provided in act approved October 8th, 1836, is hereby repealed. And that this act shall be in force and effect from and after its passage. Proposed by

Be it Resolved, By the General Council of the Choctaw Nation assembled, That the sum of fifty dollars (\$50) be, and the same is hereby appropriated to defray the expenses of scrubbing and cleaning the capitol building from December the 18th, 1882, to the adjournment of the present session of the General Council, in favor of John Freeney.

CHAHTA TAMAHA, C. N., Oct. 26, 1881.

To the General Council:

Your committee to whom was referred the petition of John A. Mitchell and others, applicants for citizenship, would most respectfully recommend the adoption of the following act:

An act to establish the citizenship of John A. Mitchell and his brothers and sisters and their children.

Be it enacted by the General Council of the Choctaw Nation assembled, that John A. Mitchell, William L. Mitchell, Vergueirs Mitchell, Anna M. Mitchell, and Mrs. Salina Y. Bonner and her children, Franklin A. Bonner, W. T. Bonner and Emily E. Bonner, are all of Choctaw descent through the line of the male family, being the grand-children and great-grand-children of Mrs. Emily Yates, deceased, who was a sister of the Hon. Robert Nail, and as such are entitled to all the rights, privileges and immunities of citizenship in said Nation, which is hereby established.

Be it further enacted, That this act take effect and be in force from and after its passage.

BILL NO. 15.

An Act establishing the citizenship of Mary M. Rogers and others.

Be it enacted by the General Council of the Choctaw Nation assembled, That Mary M. Rogers, and her husband B. F. Rogers, and their children, William F. Rogers, Mary I. Rogers and Isaac L. Rogers, and Sophia A. Flint, a daughter of said Mary M. Rogers by a former husband, are all descendants by Choctaw blood of the Krebs family, and are hereby declared entitled to all the rights and privileges of citizenship in the Choctaw Nation, and will be respected accordingly; and this act shall take effect and be in force from and after its passage.

BILL NO. 16.

An Act removing Nanih Takali precinct in Blue county, to Philadelphia Meeting House.

Be it enacted by the General Council of the Choctaw Nation assembled, That Nanih Takali Precinct, in Blue county, is hereby removed to Philadelphia Meeting House, about three miles south of Nanih Takali, and shall be called and known as Philadelphia Precinct; and this act shall take effect and be in force from and after its passage. BILL NO. 17.

A Resolution to provide for the erection of a new building for Spencer Academy.

Be it Resolved, By the General Council of the Choctaw Nation assembled, That the sum of fifteen thousand dollars is hereby appropriated out of the different funds herein after mentioned for the erection of a new building for Spencer Academy, in Kiamitia county; the location of

which having been agreed upon by the Board of School Trustees, two miles southeast of the residence of Hon. C. E. Nelson, in amounts, viz: \$900, all there is on hand out of the appropriation of November 4th, 1880, for the erection of a new building for Spencer Academy; \$3287.50 unexpended royalty funds on hand July 31, 1879, not appropriated and loaned to Superintendent of schools, but returned by him to the treasurer; \$5406.25 out of the royalty funds which accrued during the fiscal year ending July 31, 1881, and \$5406.25 out of royalty funds which shall accrue during the fiscal year ending July 31, 1882.

Resolved further, that said new building of Spencer Academy shall be wooden, two stories high, 93 feet front, with two wings from the main building, each to be 105 feet long, roof to be tin, the whole building to contain twenty-eight rooms, and shall be completed and ready for the school to be opened on the first Monday in September, 1882.

Resolved further, that the Auditor shall issue his warrant for the aforesaid amounts upon the certificate of the Superintendent of schools made by order of the Board of Trustees, and the Treasurer shall pay the same accordingly: Provided, however, that none of the said fifteen thousand dollars shall be paid to the contractors until the said new building is all completed in accordance with their contract.

Resolved further, that said Board of Trustees shall report their proceedings to the next General Council, and this resolution shall take effect and be in force from and after its passage. Proposed by

BILL NO. 18.

An Act amendatory to an act to increase the pay of county judges, approved Oct. 30, 1877.

Be it enacted by the General Council of the Choctaw Nation assembled, That whenever the county revenue in any county exceeds the sum of five hundred dollars per annum, the county judge thereof shall be allowed an additional salary of fifty dollars, and the same sum for every additional five hundred dollars of revenue until the revenue reaches the sum of fifteen hundred dollars, beyond which no additional sum per annum shall be allowed said county judges: Provided, the increase of

compensation allowed by this act shall be payable out of the county treasury; and this act shall take effect and be in force from and after January 1st, 1882. Proposed by

A Resolution for the relief of the National Light Horsemen.

Be it Resolved by the General Council of the Choctaw Nation assembled, that the sum of two dollars per day each is hereby allowed the National Light Horsemen for every day's actual attendance at the present session of the General Council, to be certified to by the Principal Chief, whereon the Auditor shall issue his warrants and the Treasurer shall pay the same out of funds appropriated to defray the expenses of the present session of the General Council. CHAHTA TAMAHA, C. N., Nov. 8, 1881.

To the General Council:

Your committee to whom was referred the recommendations of the Board of Trustees in reference to the disposition of the property at old Spencer Academy would beg leave to propose the following resolution:

Be it Resolved by the General Council of the Choctaw Nation assembled, That Rev. O. P. Stark, Agent Presbyterian Board of Missions, of New York, is hereby authorized to take charge of all the property belonging to old Spencer Academy, and sell all perishable property at whatever price he can get for it, and make use of the Academy teams in improving a piece of land, as much as possible, at or near the location for the new building for Spencer Academy, for the purpose of raising vegetables and such other produce as may be necessary for the support of the school when begun.

Resolved further, That Hon. E. W. Tims, Trustee of the Second District, is authorized to collect all accounts still outstanding and due to old Spencer Academy, and who shall make report of the same to the next General Council; and this resolution shall take effect and be in force from and after its passage.

BILL NO. 21.

An Act supplementary to the school law, approved Nov. 4, 1879.

SECTION 1. Be it enacted by the General Council of the Choctaw Nation assembled, That the local trustees of neighborhood schools shall have the right to employ teachers of good moral character and sober habits to teach in their own schools, and send them to the District Trustees for examination, and if the examination is satisfactory said District Trustees shall give them certificates to teach.

SEC. 2. All that part of the law requiring neighborhood schools not to be nearer together than eight miles is hereby repealed, and all neighborhoods that can raise ten Choctaw scholars shall be entitled to a neighborhood school; and all teachers shall be entitled to two dollars a scholar per month, and ten cents per scholar per day for every day less than fifteen days per month.

SEC. 3. Neighborhood schools shall be taught at least six hours each and every week day except Saturdays, during the term or session, and shall be opened and closed at regular hours.

SEC. 4. Local trustees shall promptly report to the District Trustees of their respective districts, the negligence, delinquency or improper conduct of any of the teachers in the instruction of their pupils or the management of their schools. Upon the receipt of any such information, the District Trustees shall immediately proceed to make examina-

tion of each case, and if the charges are sustained the District Trustees are authorized to suspend such teachers.

SEC. 5. Local trustees shall promptly sustain the teachers in enforcing just rules and maintaining good order in their respective schools, and shall require all pupils to pay due respect to their teachers.

SEC. 6. District Trustees are hereby required to visit each school of their respective districts during the months of November and April of each scholastic year, and in case they fail to visit their schools accordingly, they shall in each case forfeit fifty dollars out of their salary upon the report of the local trustees to the superintendent of schools, who shall report the same to the National Treasurer, who shall withhold the amount of forfeiture until after an examination by said superintendent of schools, who shall order it paid or not paid, as the case may be.

SEC. 7. Every Choctaw scholar sent beyond the limits of the Nation to any school, or to any school within the Nation, where no national pay is allowed, shall be entitled to receive the sum of two dollars per scholar per month as regular neighborhood school scholars, to be paid by the District Trustees, from whose districts such scholars are sent, upon the teacher's accounts properly and fully verified.

SEC. 8. That all acts, or parts of acts, heretofore passed, coming in conflict in any manner with the provision of this act, be, and the same are hereby repealed; and this act shall take effect and be in force from and after its passage.

CHAHTA TAMAHA, C. N., Nov. 7, 1881.

To the General Council:

Your committee to whom was referred the report of C. E. Nelson, National Treasurer, for the fiscal year ending July 31, 1881, beg leave to report that the Treasurer's report is substantially correct, but mistakes have been made which should not occur in official business, for instance: two warrants for \$22 aggregate were entered twice, and the amount of another being in excess of the value of the warrant as reported by the National Auditor, making \$33 credit to the Nation, which amount, together with \$3901, the amount in the supplementary report of the Treasurer and the amount from the collector at Stringtown, \$112.90, not on report, as well as \$89.65 from the sheriff of Tobucksey county, royalty on coal at Savanna, and the amount found to be on hand from the Treasurer's report, \$37,350.57, making a grand total of \$41,487.12, as the balance on hand to be carried to account current.

Your committee would further state that there is nothing on the Treasurer's report in regard to receipts from the several sheriffs on account of tax on licensed traders, or on timber shipped out of the Nation off the line of the railroad; and your committee would further state that nothing has appeared on previous reports, hence would recommend the resolution as follows:

Resolved, That the National Treasurer is hereby instructed to make a full and complete statement of all monyes or warrants received by him from the sheriffs as taxes on licensed traders since his induction into the office, to the next General Council, and that save this resolution, the report of the Treasurer is accepted as correct.

BILL NO. 24.

An Act removing Loring's Precinct, in Blue county, to Ephesus Meeting House.

SEC. 3. Thirty orphan scholars shall be selected by the District Trustees, ten from each district, one-half to be males and the other half to be females, and to be between the ages of six and twelve years, when selected to attend said orphan school, and who may be retained at said school; females until they are sixteen years of age, and males until they are eighteen years of age; and said orphan scholars, who have capacity and anxiety to further pursue the higher course of studies after they have finished in said orphan school, shall have the same right as any other scholars to attend school in the states; and this act shall take effect and be in force from and after its passage.

rules, and regulations, as other non-citizens, and all privileges herein granted shall be cancelled; and this act shall take effect from and after its passage.

BILL NO. 47.

To grant right-of-way through the Choctaw Nation to the St. Louis and San Francisco Railway Company.

WHEREAS, The St. Louis and San Francisco Railway Company has applied for permission to construct a line of Railway and Telegraph through the southeasterly part of the Choctaw Nation;

AND WHEREAS, The United States desires to obtain for the use and benefit of said Company Right-of-Way through said lands with appurtenances thereto;

AND WHEREAS, The Secretary of the Interior, with the sanction of the President of the United States, has designated Uri J. Baxter as an agent to present such application to the Choctaw Council, and he has duly presented the same;

AND WHEREAS, The said Council, upon the recommendation of the Principal Chief of said Nation, has appointed Ellis Choate, Sampson Holson, Thomas H. Byington, J. P. Folsom, Alfred Wright and J. W. Everidge, on the part of said Council, to confer with said agent of the United States;

AND WHEREAS, Said parties have agreed to and duly submitted the following:

NOW, THEREFORE, Be it enacted by the General Council of the Choctaw Nation assembled, That a Right-of-Way is hereby granted to the St. Louis and San Francisco Railway Company, a corporation duly organized under the laws of the State of Missouri, for the construction of a Railroad and Telegraph Line, said Right-of-Way to be 200 feet in width through the Choctaw Nation, and 400 feet in width at each station for a distance of 4000 feet in length; said Right-of-Way to commence at any point to be selected by said company on the line of said Nation immediately contiguous to Sebastian or Scott counties, in the State of Arkansas, and run thence in a southwesterly direction on the most direct and practicable route through the said Choctaw Nation in the general

direction of Paris, in the State of Texas; said road to continue to, or to connect with, a proposed road from the city of Paris, aforesaid.

SEC. 2. The said St. Louis and San Francisco Railway Company shall accept this Right-of-Way upon express condition, binding upon itself, its successors and assigns, that they will neither aid, advise, nor assist in any effort looking toward the changing or extinguishing of present tenure of the Choctaws in their lands, and will not attempt to secure from the Choctaw Nation any further grant of land, or its occupancy, than is hereinbefore provided.

SEC. 3. The said Railway Company shall pay for all property injured or destroyed by said company, and for all material taken and used in the construction, operation or repairs of said Road and Telegraph Line, and shall take no such material except under contract with the proper authorities of the Choctaw Nation, and according to the laws thereof; Provided, that before the construction of said road through any lands held by individual occupants according to the laws, customs, and usages of said Nation, full compensation shall be made to such occupants for all property to be taken or damages to them by reason of the construction of the said Road and Telegraph Line. In case of failure to make amicable settlements in any case, either national or individual, such compensations shall be determined by appraisalment of three disinterested referees, one to be named by the Commissioner of Indian Affairs, one by the Principal Chief of said Nation, and one by said Company. This provision shall also apply to all cases of injury to persons or property, occasioned by the construction, or operation of said Road and Telegraph Line, after the construction thereof shall have been commenced. Said arbitrators shall receive not exceeding four dollars per day for each, with mileage not exceeding six cents per mile, and witnesses shall receive the usual fees allowed by the courts of said Nation; costs shall be made a part of the award and be paid by the losing party.

In case of failure to pay such award, the Secretary of the Interior shall be, and is hereby authorized to forbid the further passage of trains, or the use of said Right-of-Way, and to remove the agents and employes of said company from the limits of said Nation as intruders under the intercourse laws of the United States, until such time as payment shall be made by said company.

And, in addition to the foregoing, the injured parties shall have the right of recourse to all legal remedies that may be applicable in like cases in the judicial tribunals; and consent is hereby given that the civil

jurisdiction of the District Court of the United States, for the Western District of Arkansas, and such other courts as may be established by authority of the United States, shall be extended within the Territory and limits of the Choctaw Nation, without distinction as to citizenship of the parties so far as may be necessary for the enforcement of the provisions of this Act.

SEC. 4. For and in consideration of the uses and grants aforesaid, the said Railway Company shall pay, quarter annually, to the National Treasurer of said Nation, to be used for the benefit of schools, herein, the sum of \$500, and until the first of such payments be made, no right or power to enter upon said lands, except for the purpose of surveying and locating its line of Road and Telegraph, shall be acquired under the provisions of this Act.

SEC. 5. Before any right shall accrue by virtue of this Act, the same shall be ratified by the Congress of the United States; and within one year thereafter the said company shall file with the Secretary of the Interior a map showing the definite location of its line of Road and Telegraph and shall complete the said Road and Telegraph through the land of said Nation within the further period of one year; provided, that after the fixing of the general route by the filing of a map of preliminary survey in the office of the Principal Chief of said Nation, who shall furnish a copy thereof to the Secretary of the Interior, no claim for a subsequent settlement and improvement shall be valid as against the said Right-of-Way.

SEC. 6. The said Right-of-Way shall not be settled upon by authority of said Railroad Company, by non-citizens of said Nation, except such employes of said company as are necessary to the successful operation of said Railway and Telegraph Line, and their families, and such persons as may be authorized by law to reside in the said Nation; provided, that only agents, operators, depot employes and section men shall be exempt by reason of such employment from payment of permits, as required by other non-citizens of said Nation.

SEC. 7. No greater rates of fare or freight shall be charged in the Choctaw Nation, by said Railway Company, than the lowest rate authorized by law in the States of Arkansas and Texas, or either of them, for services or business of the same kind; and said Railway Company agree to convey all passengers and to accept and transport all freight that may be offered, and to bill any freight which may be offered for shipment from points on said line in the Choctaw Nation to Chicago,

with the privilege of stopping said freight at St. Louis, by the shipper, on the same terms as if the bills had been made for St. Louis in the first instance.

SEC. 8. The said Railroad Company shall execute a bond to the United States to be filed with and approved by the Secretary of the Interior in the penal sum of \$500,000 for the use and benefit of the Choctaw Nation, to cover any and all damages which may accrue by reason of the failure of said Railway Company to comply with all or any of the provisions and conditions of this Act; said bond shall be good and valid against said company, its successors and assigns, and shall be renewed at the expiration of every five years, and whenever in the judgment of the Secretary of the Interior a renewal of the same shall be deemed necessary for the protection of the interests of the Indians or of the United States.

SEC. 9. If within ninety days after the passage of this Act by the Choctaw Council the company aforesaid shall fail to accept the conditions herein specified, by a resolution of its Board of Directors, certified to and filed with the Secretary of the Interior, or shall fail within one year to file its map of location with the Secretary of the Interior as hereinbefore provided, then this Act shall apply to any other incorporated company that shall have first obtained the approval of the President of United States:


